A Legacy Gift is a donation that you leave to the Child & Youth Advocacy Centre (CYAC) in your estate. In making this commitment you can have a substantial impact on brave, little survivors while maintaining your current lifestyle. Additionally, the tax benefits your estate receives from this may actually increase what you are able to pass on to your loved ones.

There are a variety of ways you can leave a Legacy Gift, whether through your will, a gift of life insurance, or designating the CYAC as a beneficiary of your RRSP, RRIF or TFSA.

OPTIONS FOR BEQUESTS

OUTRIGHT BEQUESTS allow you to stipulate a specific sum or percentage of your estate to the CYAC for which your estate will receive a charitable tax receipt.

RESIDUARY BEQUESTS are gifts made from the remaining estate once all outright bequests are fulfilled. The CYAC can be the recipient of all or a portion of the residual of the estate.

ENDOWED BEQUESTS can be made of either outright or residuary bequests. The funds left to the CYAC will create an endowment in your or your family's name. An endowment is a permanent, invested fund of which the principal may not be spent, only the invested endowment's returns may be used by the Child & Youth Advocacy Centre.



BEQUEST WORDING SAMPLE

Here is an example of some basic wording which can be used in your will. The CYAC strongly encourages you to work with your lawyer and/or professional advisor should you wish to leave a bequest to the Child & Youth Advocacy Centre.

“ To pay the sum of \$ _____ OR _____% of (my estate) or (the residue of my estate) to Child & Youth Advocacy Centre of Kelowna to be applied by the CYAC's Board of Directors at its discretion, for the general purposes of the Child & Youth Advocacy Centre.”
